34th edition of the Turkey Run took place. They arranged to have an area for us to park our Studebakers, complete with a tent, chairs, and food.

We were only able to attend on Saturday, and could only stay for about 5 hours, but they were hours well spent. To help cover some of the expenses, each car owner paid a modest \$4.00 fee. This was a far better bargain than the \$40.00 entrance fee to bring our 1956 Golden Hawk onto the Speedway grounds.

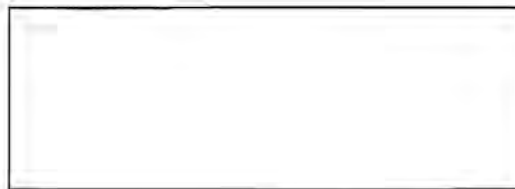

## Tips on Pumping Gas

I don't know what you guys are paying for gasoline.... but here in California we are also paying higher, up to \$3.50 per gallon. But my line of work has been in petroleum distribution for about 31 years now, so here are some tricks to get more of your money's worth for every gallon pumped.

Here at the Kinder Morgan Pipeline where I work in San Jose, CA we deliver about 4 million gallons in a 24-hour period through the pipeline. One day is diesel the next day is jet fuel, and gasoline, regular and premium grades. We have 34-storage tanks here with a total capacity of 16,800,000 gallons.

Only buy or fill up your car or truck in the early morning when the ground temperature is still cold. Remember that all service stations have their storage tanks buried below ground. The colder the ground the more dense the gasoline, when it gets warmer gasoline expands, so buying in the afternoon or in the evening....your gallon is not exactly a gallon. In the petroleum business, the specific gravity and the temperature of the gasoline, diesel and jet fuel, ethanol and other petroleum products plays an important role. A 1-degree rise in temperature is a big deal for this business. But the service stations do not have temperature compensation at the pumps.

When you're filling up do not squeeze the trigger of the nozzle to the "fast" mode. If you look, you will see that the trigger has three (3) stages: low, middle, and high. In slow mode you should be pumping on low speed, thereby minimizing the vapors that are created while you are pumping. All hoses at the pump have a vapor return. If you are pumping on the fast rate, some of the liquid that goes to your tank becomes vapor. Those vapors are being sucked up and back into the underground storage tank so you're getting less worth for your money.

One of the most important tips is to fill up when your gas tank is HALF FULL or HALF EMPTY. The reason for this is, the more gas you have in your tank the less air occupying its empty space. Gasoline evaporates faster than you can imagine. Gasoline storage tanks have an internal floating roof. This roof serves as zero clearance between the gas and the atmosphere, so it minimizes the evaporation. Unlike service stations, here where I work, every truck that we load is temperature compensated so that every gallon is actually the exact amount.

Another reminder, if there is a gasoline truck pumping into the storage tanks when you stop to buy gas, DO NOT fill up --most likely the gasoline is being stirred up as the gas is being delivered, and you might pick up some of the dirt that normally settles on the bottom.

Hope this will help you get the most value for your money.

I filled my ice chest and set out again. About 30 miles went by and I got really sleepy. So I pulled off the road by a small convenience store, and took a nap. Woke up about 2:30 AM and set out again. 2 more hours went by and I took another nap on the frontage road between Tucson and New Mexico. I almost hit a coyote as I pulled off the road.

Woke up again at 5 AM. The truck is just humming along so well despite low oil pressure. About 7 AM I make it over the New Mexico line and soon I'm into Lordsburg, New Mexico. I gas up here and across the street is Elderberry's Restaurant. I had my first ever skillet breakfast there: Steak, onions, peppers, and potatoes with 2 eggs on top. It was really good.

And on I went. The desert was greener here but the road

Really desolate.

I gas up again at McElhaney, Texas again - it seems Texas just goes on and on. I'm only getting about 12 M.P.G. Finally at about 9:30 PM, I get to a rest stop near Kerrville, Texas on my way towards San Antonio, and bed down for the night. My headlights are cutting off and on again.

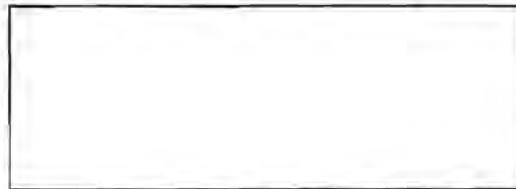

## **My First Studebaker R2 Driving Experience**

*or Why Tailgating in South Bend is a Good Thing!*

It was another beautiful day in Southern Georgia. The date was April 11, 2008, and the South Georgia Chapter of the Studebaker Drivers' Club was hosting the 5th Annual Georgia State Meet, in Albany. This meet was looking to be one of the best thus far. Some outstanding cars were to show up, and lots of wonderful Stude-Lovers were to attend. My good friends, Joe and Nancy Bacon, were driving all the way from Indianapolis, IN, just to attend this meet. And even better than that, their '63 Daytona R2 was in the trailer coming with them. I'd heard all about Freddy's Daytona from several prominent SDC guys, all saying that it was one of the nicest Daytona HT's in the country, and one of the fastest as well. Well, Joe liked the car so much; he sold his '70 Corvette to buy it. After swapping several emails over the next few months, and seeing a couple pictures of the Daytona, I just HAD to see it for myself, someday or another! It wasn't long before Joe told me that he and Nancy were planning to drive down to the GA Meet in April, with the Daytona in tow. I don't think I'd ever been more excited! Not only would I get to reunite with my tailgating buddies from South Bend, but I'd also get to lay eyes on one of the best '63 Daytona HT's extant. I was secretly hoping to go for a ride in this car, and knowing Joe, I knew I'd get one. But, it got better than that. He told me I was to actually DRIVE this car! I've only driven a couple of 4 speed cars as it is, and never an R2. I couldn't believe it. This meet was going to be one of the very best yet.

So, getting here as fast as Christmas, April 11th finally rolls around. Mom said it was OK for me to play hooky from school that day, so my granddad and I loaded up and headed west for the meet. Just as soon as we arrived, I spotted a shiny black '63 Daytona hardtop. There it was!! I nearly lost my breath at the sight of that thing. I knew I really should go and help my granddad unload the car off his trailer, but I couldn't resist, I just HAD to go and give South Bend's Finest a once over. It was exactly like I pictured it; nearly flawless, and yea, it had the Orange Whirly Thing under the hood. And the sight of that DID take my breath away for a moment! Shortly after, I fetched my 'Official-Studebaker-Meet-Tailgating-Fold-Out-Chair', and joined Joe and Nancy for some good Studebaker conversation. (Regular R2's don't REQUIRE 114 Octane gas, if you get what I'm tryin' to say here.) I make it to the street, leave the parking lot and head on out. Still getting used to the car, I pushed the throttle down a little more, I get pushed into the back of the seat, and the car just launches off. Hehehe! This thing was AWESOME! ## Studebaker National Museum

### Pays Tribute to Lincoln

**SOUTH BEND, Ind.** - While not referring to the popular Ford Motor Co. model, the Studebaker National Museum is preparing to honor a Lincoln, our nation's 16th President, during a special event held on Feb. 8 when it will unveil its newly conserved Lincoln carriage and kick off the opening of the museum's newest exhibit, The Faces of Lincoln.

The Feb. 8 event at the museum will be open from 6 p.m. - 9 p.m. and marks the beginning of a three-year bicentennial celebration of President Lincoln's birth. The event is open to the public. Tickets are \$25 at the door.

The Studebaker National Museum, in cooperation with the Indiana Historical Society, will be kicking off this celebration with The Faces of Lincoln traveling exhibit.

Abraham Lincoln's carriage was one of the first vehicles to enter the Studebaker Corporation's historical collection and has become one of the Studebaker National Museum's most cherished pieces. The Studebaker National Museum recently received the Save America's Treasure Grant to conserve vehicles and carriages that have been designated national treasures.

Brian Howard, the conservator, will be at the event to unveil Lincoln's carriage and give a presentation about the process of conserving the carriage.

The Faces of Lincoln is a three-part exhibit that is comprised of holdings from the Jack Smith and Daniel R. Weinberg Lincoln collections from the Indiana Historical Society, along with Studebaker National Museum's President Lincoln Carriage to create an informative display designed to chronicle President Abraham Lincoln's life from his early years to his assassination and its



aftermath.

The first section of the exhibit takes a look at the history of photography using some of the best and most well-known images of Abraham Lincoln. Part two investigates the ways that photographers, printmakers, and cartoonists tried to influence public opinion about Lincoln by altering his appearance and by placing him in make-believe situations.

Viewers of section three are challenged to look closely at the images and try to determine what kind of images and symbols the printmakers used to convey their, and the nation's, feelings toward Abraham Lincoln.

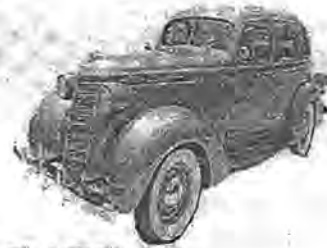

## Just Out Of The Showroom The Art Of Washing A Car

The next time you wash your car, treat it to a hand wash. Hand washing is easier on your car's finish

and will give you better results. Start with the tires and wheels and switch to a different mitt once you're finished. Using the tire mitt on the body can leave unwanted particles on the paint.

High-quality cleaners for tires and rims will ensure a longer lasting shine. Most of the dirt that appears on wheels comes from brake dust. A good quality rim cleaner will repel this dust, leaving the wheel looking like new longer.

When washing the body, be sure to use a product designed to be used specifically on car paint. Some household cleaners, such as dish detergent, can damage the finish. Start at the top and work with gravity, making your way downward, washing one section at a time. Rinse each section thoroughly. The rear of the car should be saved for last since it often gets the dirtiest and can contaminate the wash mitt.

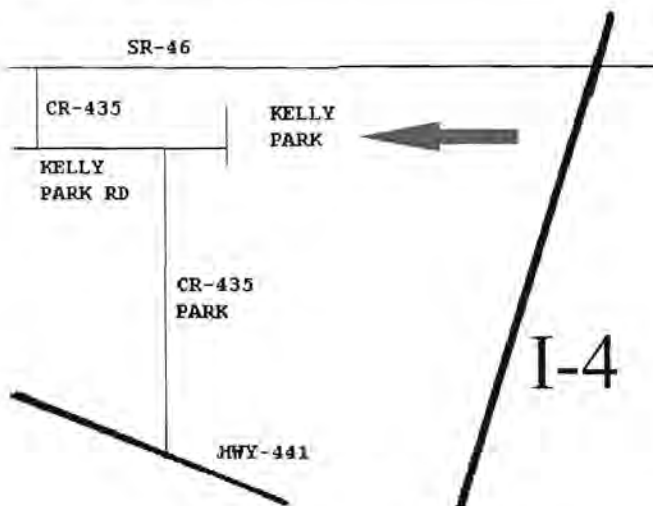
